Frequently Asked Questions

What if I'm not ready for treatment?

That's ok! When you feel a little more ready you can reach out to a number of community providers and recovery organizations that can help you get on the path to recovery! It's important to understand that treatment can still be successful even if you're not quite ready. You don't need to be willing to completely stop or have "hit bottom" in order to move toward a life of recovery.

Will I be arrested if I call 911 when there's been an overdose?

Florida Statute 893.21 provides that a person acting in good faith who seeks medical assistance for an individual experiencing, or believed to be experiencing, an alcohol-related or drug-related overdose may not be arrested, charged, prosecuted, or penalized for certain drug charges, including use or possession of drug paraphernalia, possession of less than 10 grams of a controlled substance, and possession of 20 grams or less of marijuana. Please see FLorida Statute 893.21 for more information.

Can a person re-overdose after the Naloxone (Narcan) has been given?

Yes, depending on how much the person used and the type of opioid they used, Naloxone lasts for about 30-90 minutes, so it is possible that at the end of that time, the person could re-overdose. This is why it is important to call 911, even if you have Narcan on hand.

1. Language matters – it is important how you talk about addiction and recovery
2. Ongoing recovery monitoring and management remains important
3. Do not give up hope if you encounter a recurrence of your disorder
4. Early intervention results in earlier remission

7. Families suffer too – they need independent help and objective input
8. Abstinence is not the only way to remission, but it is often the safest

- The inability to control opioid use
- Uncontrollable cravings
- Drowsiness
- Changes in sleep habits
- Weight loss
- Frequent flu-like symptoms
- Decreased libido
- Lack of hygiene
- Changes in exercise habits
- Isolation from family or friends
- Stealing from family, friends or businesses
- New financial difficulties
